This past year I introduced a yearly theme of Achieve, Believe and Proclaim challenging our committees and congregation to act upon these words in both our work here inside the church and out in the community. I wanted to take a second on talk about how we have accomplished this theme.

So, what have we achieved?

- We have achieved another fiscal year coming in under budget thanks to reduced salary and benefit expenditures, a mortgage that was paid off early and we now have \$40,000 invested in CDs earning us interest.
- Pastor Jan has renewed her interim contract for another 6 months starting January 1, 2025, showing dedication and an invested commitment to Resurrection.
- We have more members involved than ever across the board, whether it be with the PI team, CODO (Carbon Monoxide Detector Outreach), Men's Club, Book Club, Community Garden or any other active committee.
- Two new members, Tony and Jody Kluender were welcomed with warming conversations and friendly faces and joined our church. Others keep visiting us regularly as well and we hope full suit.

So what do we believe?

- We believe there is one God.
- Jesus Christ is the Son of God.
- The Death and Resurrection of Jesus Christ.
- Salvation by Grace.
- Belief in Eternal Life.
- That we will continue to grow and strengthen in our outreach efforts with our neighbors in the community.
- That God will continue steering the Resurrection wheel in the direction he sees best for 2025.

So how have we proclaimed?

- We have opened our doors to the community with two concerts, 3 car shows and the 2nd year of hosting a Veteran's Day service.
- We had a successful kick-off to our ongoing service project, CODO, keeping people safe in their homes, with another event scheduled for January.
- Another successful Chili Drive sent \$3,324 to the diaster relief funds.
- Our 2nd Blessing of Pets assisted the needs of 3 different centers in our immediate community.
- At-home communion has been established, something not seen since Pastor Ken's tenor.
- A bountiful harvest of fresh produces was shared with Crisis Food Center and those in need.
- Online worship continues to be made possible by the Resurrection Tech Team.
- All of us involved have extended ourselves in outreach efforts via making new acquaintances and contacts during these events, even if it was just saying Hi, I'm ___.

I do believe this list for achieving, believing & proclaiming goes on, with many other Resurrection involvements that have slipped my mind upon writing this. I would say that's quite impressive for the 40 or so of us that regularly gather here on a weekly basis to make all of that happen. Thank you!


Un-hanging of the Greens will take place **Jan. 5th, following worship**.

Highlight's from Church Council – December

REPORTS

- * Treasurer's Report: Total offering for the month was \$10,161.62. Total income for the month was \$10,653.30. October and November are typically lower months for offering, so historically this is in line with our giving. Total expenses were \$13,150.99. We had additional expenses related to the Veteran's Day Service and an extra two weeks of mowing. Cash flow for the month was -\$2,497.69
- * President's Report: A letter was received from the Call Committee recommending that Council interview Pastor Mauricio Vieira who recently responded to our call for a full-time pastor. This would have been the next step in the process of a call. After serious conversation with the Council, Neal called an emergency meeting between the Call Committee and the Church Council that took place on Dec. 22. After nearly two hours of in-depth, rather heated conversations, and a lot of emotions, some very challenging decisions were made. These will be shared with the congregation in small, personal one-on-one meetings to be arranged in January. You will be receiving a phone call to schedule a time to meet soon.

* Pastor's Report:

- Pastor announced our newest member Jody Kluender has asked to serve on the Worship Committee. We are thrilled to have her already becoming involved.
- Adult Study just began a video series focusing on the Gospel of Luke that will run for 12 sessions.
- Resurrection's Afternoon at the Movies to begin in January with a date to be announced.
- Pastor's contract expires December 31. Pastor and Neal have signed another 6-month interim contract. Pastor is working on completing a Rostered Minister Profile to be interviewed by the Call Cmte. for a permanent part-time position at Resurrection.

COMMITTEE REPORTS

* None at this time

NEW BUSINESS

* One of the stoves in the kitchen has a blown motherboard. Due to age and the cost of replacement parts, Council approved a new stove up to \$700. The Callahans will take care of shopping and purchasing the new stove. We are truly blessed to have them help maintain our property.

I CONTINUING BUSINESS

- * The Properties Committee sat down with Council to review and approve the contract for a new roof. Upon their recommendation, Ryan Roofing at the cost of \$38,520. This money will be taken from the Reserve Fund and the Major Repair Fund which will have no balance upon paying Ryan Roofing.
- * Concerns with the cleaning service being up to par were mentioned. Those involved with hiring the company will continue to watch for any issues as those mentioned are trivial at this point in time.
