### I. PRESIDENT'S REPORT

The year 2024 was a different kind of year for me personally in my spiritual and church life. Having served two full terms on the Church Council as an at-large member, with my 2nd term ending in December 2023, I was anticipating a pause from Council life. I thought I would be taking a break and continue with my duties as the newsletter editor and maintaining the church's website, tasks I've done for the past several years. However, it appears that our Lord had other plans, as I found myself being asked more than once to consider serving as the next President. This role was something I had personally never seen myself doing. I just didn't think I was the person to fill those shoes. Accepting the position came with a few stipulations, like Council being able to work around my challenging schedule that lacks in consistency and availability. They graciously accepted the possibility of last-minute cancelations or reschedules, I was nominated, voted in and the fun began as the new President of Resurrection.

The first couple of months of 2024 quickly presented some challenges to this new President, including having to find a new Vice President as the former moved away. Then I had to find a replacement for an at-large member. The replacements I sought out and asked to step-up were a definite asset to an already rock-solid church Council. A Council whose support I am very much appreciative of. They are to be commended for their time, dedication and valuable input. Thank you!

Other challenges naturally surfaced throughout the year, including the retirement of our organist which came as quite the surprise. "Ask and you shall receive" demonstrated itself again, as our previously retired organist blessed us with 7 more months of uplifting hymns and music. It seems that God had a reason and a plan for everything that confronted us, leading us through the obstacles. I cannot forget that many of these were often benefited by the support and guidance of Pastor Jan Worms. She was an absolute blessing to me with her experience and wisdom, sometimes at 10:00 pm. Thank you, Pastor Jan, for being just a phone call away!

This past year I also introduced a yearly theme, **Achieve, Believe and Proclaim**, something not done previously. I challenged our committees and congregation to act upon these words in both our work inside the church and out in the community. I wanted to take a second and highlight what we accomplished.

What did we **Achieve**? We achieved another fiscal year coming in under budget thanks to reduced salary and benefit expenditures. Our mortgage was paid off early and celebrated with a wonderful catered luncheon. We invested \$40,000 into CDs now earning us interest. Pastor Jan renewed her interim contract twice, showing dedication and an invested commitment to Resurrection. We also saw more members involved across the board, whether it be with the PI team, CODO (Carbon Monoxide Detector Outreach), Men's Club, Book Club and/or the Community Garden. Two new members were also welcomed by warming conversations and friendly faces. Others kept visiting regularly as well.

What did/do we **Believe**? We believe there is one God, and that Jesus Christ is the Son of God. We believe in the Death and Resurrection of Jesus Christ and Salvation by Grace. We believe in Eternal Life. We believed that our outreach efforts would continue to grow and strengthen our relationships with our neighbors in the community. We believed that God would continue to steer the Resurrection wheel in the direction he sees best.

How did we **Proclaim**? Resurrection opened our doors to the community with two concerts, 3 car shows and the 2nd year of hosting a Veteran's Day Service. We had a successful kick-off to our ongoing service project, CODO, keeping people safe in their homes with new carbon monoxide detectors and fire alarms. Another successful Chili Drive sent \$3,324 to disaster relief funds. Our 2nd Blessing of Pets assisted the needs of 3 different centers in our immediate community. At-home communion was reestablished. A bountiful harvest of fresh produce was shared with the Crisis Food Center and those in need from our Community Garden. Online worship continued to be made possible by the Resurrection Tech Team. And for some, they simply extended themselves via a hello.

I would say we more than demonstrated Resurrection's mission to share God's care, invite people personally and virtually into community, and offer opportunities to grow and serve. The list

for **Achieving, Believing & Proclaiming** goes on, with many other involvements that probably slipped my mind upon writing this. As Church President, I am just one small piece of the whole. I would say 2024 was quite an impressive year for those of us that regularly gather for worship and make all of this happen.

Thank you for your support and looking forward to and even more rewarding experience as your President in 2025.

#### Resurrection Lutheran Church Annual Congregational Meeting November 17, 2024 11:00 a.m. *We are an inviting community of faith where we care for all.*

- Neal Booth opened by meeting by welcoming everyone in attendance. He began by informing everyone of some of the work that the council has undertaken this year and of some major expenses that will need to be approved to update our building.
- Attendance was taken to ensure that a quorum was reached. The result was 38 members attended, and a quorum was reached. Distribution of previous year's congregational meeting minutes, nominating committee roster, proposed budget and agenda was completed.
- No corrections were found in the November 2023 Annual Congregational Meeting. A motion was made by Neal Booth to accept the minutes as written. Mark Groh seconded the motion. The motion passed.
- The 2025 proposed budget was presented by Kay Tucker. She explained that the budget has a negative balance due to the budget reflecting the hiring of a full-time pastor. We are in good shape. She noted that we made a contribution of \$1,900 for hurricane relief. A correction to the 2025 budget is an increase of the line item for "Soups On" from \$900 to \$1,200 due to the food prices. A question arose from the floor, Jim Lieber, regarding the line item of Trash Removal. Kay explained that this subject keeps coming up and budgeted \$500 in case we choose to use a service. Rich Kelley made a motion to accept the 2025 budget, along with the above correction. Dan Callahan seconded the motion. The motion passed.
- The Nominating Committee presented the positions to be filled for 2025. They are Bob Doerr as Vice President, Teresa Droste as Secretary, Sherry Wyatt & Mark Groth as at large members. 2024. There were no additional nominees from the floor. The new Council members were accepted by acclamation.
- Neal reviewed the bids that have been received on replacing the roof shingles and replacing the front doors to be more energy efficient. He explained that due to the amounts of the expenditures, the congregation needed to approve the council spending the money. Discussion took place from many people in the congregation about the contractors and which ones the council should consider. Ryan Roofing and Lyons seem to be the favorite of many people. Kay said that the money for these expenditures will not be a burden to the church as we have money in CDs. Sharon Groh made a motion, that with the council doing their due diligence, to approve the expenditure for the roof. The motion was seconded by Rich Kelley with the understanding that the Property Committee be involved. The motion passed.
- Discussion then turned to the replacing of the front doors. Carol Callahan brought up that the congregation can help pay for the doors (and the roof) by contributions. Rich Kelley made the motion to approve the council spending the money to replace the doors with the Property Committee involvement. The motion was seconded by Mark Groh. The motion passed.
- Tim Belfield mentioned that the Nominating Committee for 2025 needs to be approved. They include Alan Robertson, Elyse Tillman and Kay Tucker. Neal Booth made the motion to accept Alan, Elyse and Kay as members of the 2025 Nominating Committee. Mark Groh seconded the motion. The motion passed.
- Neal then asked if there were other items to be discussed. Mark Groh wanted to thank Dave & Ann Isringhausen for the donation of the trailer that was used for the Community Garden. He told the attendees that over 1,000 pounds of vegetables were harvested. Dan Callahan advised that the water drains have been replaced and secured and thank Rich Kelley for the replacement of the water lines to the garden.
- Pastor Jan Worms closed the meeting with reciting the Lord's Prayer.

### **II. COMMITTEE REPORTS**

#### **Social Ministry**

Members: Ann and David Isringhausen, Carol Garner, Mark and Sharon Groh (Chair)

With the participation of congregation members, the following community and congregation-focused ministries were engaged:

The activities of the Social Ministry Team were incorporated into other committees and outreach activities of the church and community. Member medical needs and sadly, death prevented formal meetings from being a priority. Our faith was expressed in service beyond this Committee. We believe we drew strength through visitation and phone contact.

The Card Ministry was expanded by encouraging all members and friends to send cards, especially remembering those unable to attend worship services or other church activities. A carousel filled with donated greeting cards was placed in the narthex to make it easier to share in this effort.

An outreach training in partnership with the PI Team (Planning & Implementation). Training focused on 1) writing and use of press releases, and 2) creative development and sharing of marketing / outreach materials. The training will be repeated as we strive to improve how we proclaim God's word through telling our story in the community and welcoming all. This training was an example of recognizing our spiritual gifts and how to use them in daily life.

The Alton Crisis Food Center received food donations from the Resurrection Community Garden during the long growing season, in addition to the food left in the donation barrel. Members are always responsive to requests for food. The grocery list bulletin inserts of most-needed-items proved helpful. The "Happy Birthday Bags" are a welcome treat for families but could benefit from additional promotion. We want to recognize members who provide monetary donations in lieu of food due to difficulties getting to the store for purchases. All forms of help are appreciated as the growing need for food continues to exceed resources. A Fall visit to the Center by a group of Resurrection volunteers was an informative experience. The Center includes a clothing store and accepts donations. Prayerfully consider volunteering.

- The ELCA World Hunger celebrated its 50<sup>th</sup> anniversary in 2024. Our congregation was represented on scheduled webinars and information shared with members.
- Resurrection contributed 246 non-perishable food items to the Troop #7 Scouting for Food annual service event. This was combined with several vehicle loads collected throughout Godfrey donated to the Alton Crisis Food Center.

The Oasis Women's Shelter for victims of domestic violence provides on-site shelter, counseling, and support services. Repeated donations of garden vegetables and personal care items were received with gratitude. God's Work. Our Hands. Sunday was a culmination of several months of planning that resulted in the *"Resurrection Church Smoke Alarm / Carbon Monoxide CO Detector Day of Service. A Community Partnership Project with Alton Fire Department, Godfrey Fire Protection District, and Boy Scout Troop 8007"*. The September pilot event was evaluated and determined to be a success. We achieved our goals of setting up an infrastructure to support applicant information, coordination with local fire departments, we developed a database to record donations, volunteer participation, device inventory, and have a baseline for community outreach. We also created a homeowner Waiver of Liability, with input from the church insurance carrier and a legal professional. The consensus of the participating volunteers was to continue soliciting donations to enable quarterly carbon monoxide installation events for Alton & Godfrey homeowners.

In October, recognizing the research-based health benefits and emotional importance of pets to seniors, members helped achieve our social ministry outreach mission within our community by supporting our elderly neighbors struggling to pay for pet food or cat litter. We held a month-long drive to collect these items, and monetary donations. Proceeds were shared with local animal rescue organizations and Senior Services Plus for client

distribution, as needed. A re-packaging party for large bags needing to be re-sized for distribution followed worship and the Blessings of the Pets service.

We have church volunteers working with our unhoused neighbors during winter months at the Alton Overnight Warming Location (OWL) when temperatures drop to 20 degrees or lower. We've met elderly people, young people, people with disabilities, students, men and women who are in danger of hypothermia, frostbite and other medical risks in dangerously cold weather. Folks are offered warm meals/snacks provided by local organizations and restaurants. They have access to showers, laundry, companionship and a cot with a clean blanket and pillow, in a clean, safe location. A "department store" is available where they can select from donations of sleeping bags, clothing, shoes/boots, personal hygiene items, etc. Volunteers are provided with training and typically serve three hour shifts. OWL hours are 5 pm – 8:30 am at Deliverance Temple, 1125 E 6<sup>th</sup> St, Alton.

Our Advent Giving Tree was a true testament to the power of generosity and support of the individuals and families served by <u>Riverbend Family Ministries</u>. Thank you to everyone who donated sleeping bags, personal care items, towels, kids clothing, gift cards, arts & crafts supplies, household cleaning supplies, hats, gloves, socks, and/or cash. Some of the gifts were directed for therapeutic staff in helping children and families heal from the trauma of violence and abuse.

• Throughout the year we continue to raise awareness of the nonprofit programs and partnerships that serve together under one roof, providing families and individuals with the tools they need to be self-sufficient. RFM focuses on children, youth, and families who've experienced trauma, most often due to violence, addiction, poverty, and homelessness.

We provided support to congregation and community members with medical transportation, meals, informing of community resources, and healthcare advocacy, as needed.

Charter Organization support for Boy Scout Troop #7 is ongoing. We have active engagement at monthly Troop Committee meetings and special Scout events. A Boy Scout Handbook and Merit Badge Book, with related documents are available in the narthex and on a bulletin board in the hallway for everyone to get ideas on how you might become involved. Assistance with Scout events is routinely offered and invitations for Scout roles in church activities are extended.

Immigrant Ministry opportunities are unfolding to us as a church that proclaims a mission statement: "We are an inviting community of faith where we care for all". Throughout 2024 we have periodic Hispanic visitors who have made their home in Alton & Wood River. Thank you for welcoming them and offering support. As a congregation within the ELCA we are provided guidance and tools about what it means to walk alongside immigrants and refugees as a matter of faith, not as a political issue. While we may have different ideas about how to fix a broken immigration system and may have different ways of loving our neighbors, our call to love our neighbor is central to our faith.

The Graceful Nails Ministry with Evergreen Supportive Living was discontinued in 2024. Between two to eight residents received basic nail care, hand massage and conversation each month. Resurrection members donated supplies, but additional volunteers were not available to help, and it became too much for one volunteer to sustain alone.

The Worship and Music Committee meets at least quarterly on the first Sunday of the month, after Worship.

#### **Memorial Committee**

The Memorial Committee met on June 10. Those present were Pr. Jan Worms, Neal Booth, John Droste, and Dan & Carol Callahan.

Various projects were discussed, including new front doors, replacing the green cloth fence with a vinyl fence, replacing the organ, putting on a new roof, improving the look of the Narthex, changing the lighting in the Sanctuary and Young Hall to LED lighting, and replacing the brick planter box in the front of the church.

Our current front doors do not seal properly and therefore we lose heat and air conditioning through them. The green cloth fence is torn and some of the gromets no longer work. The organ has some issues...although currently functioning, it will need to be replaced at some point. The Narthex could be made to look for inviting to visitors with some new furniture. Changing out all the lighting would save us money in the long run, but is an expensive undertaking right now. The brick planter box is splitting at the corners. It has been fixed at least once, but the problem reoccurs because of the drainage with the box itself.

After considerable discussion, a vote was taken and the recommendations from the committee were to replace the front doors and replace the brick planter box.

#### **Finance Committee**

The Finance Committee met on October 9 to develop the 2025 Budget for Resurrection. Those present were Pastor Worms, Neal Booth, Dan & Carol Callahan and John Droste.

Working off the template of the 2024 Budget and projections of the end of the year, 2024, we came up with a budget. There were small changes, including an increase in Building & Grounds Maintenance, the Major Repair set-aside, Mowing costs, and Pastor Jan's Retirement. The budget shows a deficit of \$29,534, largely due to the inclusion of the cost of a full-time pastor.

The Budget will be presented to the Council for their approval at the October meeting, and then forwarded to the Congregation (with any changes) in November.

### Audit Committee

No Audit was conducted in 2024. The Church Council, Financial Secretary and Treasurer continue to implement many of the suggestions made in the previous audit. Necessary modifications to the budget and/or budgetary line items are periodically made to keep our books current and accurately reflecting the financial status of Resurrection Lutheran.

#### **III. AD HOC COMMITTEE REPORTS**

#### **Call Committee**

Yes, it seems this year has been a quiet one for the Call Committee. We did have 2 potential nominees during the year. The one in May was unpublished to the Council and the congregation as the sequence of events listed below will explain that nothing need be reported. The nominee was outside our synod. Had been actively seeking a pastoral call in another synod for about a year without success. The nominee requested placement as a rostered minister in our synod and was accepted. Pastor Amy contacted the Call Committee through verbal communications with information on the possible nominee. The call Committee met in mid-May to discuss. After raising some concerns about the nominee, it was decided that we should proceed with discussion and clarify our concerns. After relaying our desires with Pastor Amy and her discussions with the nominee, the nominee withdrew the Roster Minister Profile from our synod. The Call Committee did not receive the Rostered Minister Profile and did not talk with the nominee.

In mid to late June Pastor Amy sent information about a different way to look at our church through a study system called "Discover and Invite". Requesting that the Call Committee be the driving force to form a team and Pastor Jan to lead the discussion. This is a rather demanding commitment for 7 sessions, meeting every other week and each session requiring 2 to 2 ½ hours per session. Members of the team would be as many members as possible of the Call Committee that can commit, a couple from Council and 1 or 2 from the congregation, hoping for 6 to 8 total. Initially Janet Broche, Mark Groh and Rich Kelley agreed to be on the team. I was not very diligent in taking on this task. Over the next several months additional people were asked but additional members could not be added. Decided to take a step back and try again later. The later date came in November but was set aside due to the 2nd nominee.

In late summer/early fall, Cheryl Marghario stepped down from our committee. She was grieving the death of her son, and her health was making it difficult to attended meetings and especially to be involved with the Discover & Invite meetings.

The second nominee came the week before Thanksgiving in a phone call from Bishop Busboom. This is very unusual as we typically get a heads-up from Pastor Amy about a possible nominee, not a call from the Bishop. The nominee is originally from Brazil and is a second career pastor in our Synod. I exclaimed to Bishop Busboom that this is bad timing with family coming into town for Thanksgiving next week followed by Advent and the Christmas holidays. It will be difficult to carry on with the process in a timely manner. He understood but felt we should proceed as quickly as possible. All that said, what do you say to the Bishop, but we will do our best to proceed. I informed Pastor and Neal of the situation as we prepared to proceed.

We immediately received the Rostered Minister Profile. We met before Thanksgiving to review. All were impressed with the pastor's profile especially the interactions with youth, even though we have only a couple of youth. The nominee has quite an educational background and is around 50 something in age. Being from a foreign country was intriguing to us. Unanimously, we agreed to proceed with a meet and greet.

Met with Pastor Viera and his wife on December 6<sup>th</sup>. In the afternoon they were taken on a tour of the area. Both liked the area of both Alton and Godfrey. Met back at church for dinner and fellowship. It seemed to us, The Call Committee, that both would be involved in ministry here at Resurrection. Very pleasant and enjoyable evening.

After the initial meeting the Call Committee unanimously agreed to proceed with an interview. Looking at everyone's schedule the only time to meet was the following Friday or delay until after the first of the year. Not wanting to delay a month we had a very good interview on December 13<sup>th</sup>. Pastor Viera understands that we want to grow our church but that is not something he can promise. But what he could do is help us do the work and let the Spirit take care of the rest. He likes what we have going here and would help us get more involved with other churches, our neighbors and the Alton/Godfrey community.

Following the interview Pastor Viera wanted to proceed with the call process as did everyone on the Call Committee. I informed Pastor Amy and she wanted to send Neal the Rostered Ministry Profile right away, but I asked her to hold off until Council was informed.

A Letter of Recommendation was given to the Council President and Pastor Jan on the following Sunday.

On Sunday December 22nd, the Call Committee met with Council as Council was concerned about calling a fulltime pastor. The Council raised the points that a full-time pastor was not needed. The Call Committee pointed out that a full-time pastor can do more than a part time simply having more time to do so. And this pastor was wanting to reach out to the community more than a part time pastor can. The other concern was the financial expense. Yes, it would be a stretch. Yes, we have had difficulties in the past and yes, we have some larger expenses coming up. It would require a leap of faith by the Council and congregation. The Call Committee urged the Council to at least talk with the nominee and perhaps the financials could be worked out. Council elected to end the call.

The Call Committee and Pastor Viera were very disappointed. After conversation with Pastor Viera, he remains hopeful for us and believes that the Holy Spirit is still at work here and with him and this was just not meant to be.

The Call Committee remains in place and will continue with the Discover and Invite which now includes Jan Broche, Rich Kelley, Neal Booth and Sharon Groh. Mark Groh because of his work schedule has stepped down, as Pastor Jan wants to have the meetings during the day and not in the evening.

#### **Faithful Innovations Team**

The Faithful Innovations Team did not officially meet in 2025. Several things contributed to this. In December 2023 Pastor Elise Rothfusz, our Synod liaison for Faithful Innovations retired and no replacement was named. Our coach Ellen Koester had moved to Georgia in the summer of 2023. With all the administration changes in our Synod and the uncertainty of the Faithful Innovations program, we found ourselves on our own without Synod direction and without a coach. In addition, David Isringhausen was not able to remain on the team due to health issues. Gary Neese had a year that work consumed his time for most of the year. Despite these challenges the team remains.

Faithful Innovations Team members remain active as we have partnered with Social Ministry helping with God's Work Our Hands and other activities. Team members are also involved with the PI Team.

The Synod has assigned Jason Fisher as the liaison for Faithful innovations. He contacted me on August 26<sup>th</sup> about a training session on September 14<sup>th</sup>. Being out of town at the time and the 14<sup>th</sup> being a workday at church, and the following weekend was the car display, I was unable to make any arrangements for anyone to attend. If we get some guidance and direction from Synod, we may get the team up and going later, but for now we will use our resources in Social Ministry, PI Team, Evangelism training in March, which will be followed by the Discover & Invite process in May.

We have enough work to do with limited people to do it. My thanks to all who have diligently served on this team. I hope it was a good learning experience for both this team and the congregation.

I've enjoyed a wonderful year serving you at Resurrection and I think we've had a good year together. We've accomplished quite a bit together. It is a continuing joy, honor, and privilege to serve as your Interim Pastor.

#### Membership

#### Staff

Russ Henkhaus resigned as our Director of Music, citing a desire to retire. His final Sunday was June 30, 2024. Ken Rueter filled in as our organist until his resignation December 25, 2024. A search for a permanent musician to serve us continues.

Council approved increasing my contact to include two weekdays to serve you. Previously my contract was for one weekday of service. This additional day has allowed me to have more time for appointments, meetings and parish visits. I greatly appreciate this additional day and believe it has been a benefit Resurrection.

#### *New in 2024*

We have a couple of new things at Resurrection in 2024.

2<sup>nd</sup> Sunday Lunch Bunch provides an opportunity for us all to enjoy good food and fellowship. It has been well received with about eight to fifteen folks participating each month.

**The PI Team (Planning & Implementation Team)** was created in May 2024 with the approval of our Council. The purpose of the PI Team is four-fold:

- 1) Recruit volunteers to distribute Holy Eucharist to home bound members every other week. Volunteers will be trained by me and I will prepare a handbook for volunteers to use when they visit.
- 2) Outreach. Continued outreach to our neighbors and community is vital to the present and future of our church.
- 3) Committee/Team Structure. We have committees that don't function or haven't functioned for a long time. What do we need? Do we need all of them or just some of them? Should we combine or eliminate some of them? What do we need to do the mission and ministry here at Resurrection?
- 4) Long-Range Planning. We have no long-range plans. This is not good. Long-Range Planning will help us to set our goals, accomplish our mission and ministry in this place, and help guide the future of our church. Plus, our Constitution requires that we have a long-range planning team.

All of these purposes are more than council can accomplish and more than only I can accomplish. We're stronger when we work together.

In 2024 the PI Team established **Homebound Communion**. Homebound members receive Holy Communion every two weeks, delivered to them by a volunteer member. We have eight volunteers who bring communion to three people. I prepared a manual to use when bringing Communion, trained the volunteers, trained the Worship Committee members to prepare and clean up the portable communion kits used by our volunteers, and I am a part of the rotation of volunteers to bring Communion. The church now owns three portable communion kits, in 2023 we owned only one. Having three kits ensures that there is always a kit prepared and "ready to go" whenever needed.

The PI Team has been working on **Outreach** (or call it Evangelism, or Community Engagement). What the PI Team has accomplished and has in progress for Outreach.

Our "Little Book of Prayer" is an outreach tool and a prayer book created by "yours truly." Our talented Janet Broche designed the cover and made it happen. We've created a ½ page card highlighting our upcoming events.

We prepared a ½ page information and invitation folder which our Men's Group included in each bag of chili during the Chili Drive-Thru in October.

We placed stickers with "Donated by Resurrection Lutheran Church" on items gathered during our October Pet Food/Items Drive in Octobers. The purpose of this is to simply "get our name out there," to help raise awareness of our church and what we are doing.

Sharon Groh led us in a very helpful Press Release Writing Workshop. This will be repeated in 2025.

We formed a Sub Team to work on updating our Trifold color brochure and to create a series of rack cards to provide further information about our church, our worship and our life together. This is an on-going project.

In the months ahead the PI Team will work on our Committee Structure and Long-Range Planning.

Perking along nicely are all of the things we implemented in 2023: Sunday Morning Adult Study. Now called "Lifelong Learners, Blessing of the Fields and Commerce in Spring, Blessing of Pets in October, Evening Prayer during Advent and Lent, Veteran's Day Worship with the Community Invited, Wood Care Day, Providing ELCA Advent and Lent Resources during Advent & Lent, Hanging/Unhanging the Greens as a parish wide event. I look forward to continuing to serve you and to do ministry together at Resurrection. I believe that the best is yet to come for our vibrant, engaged church.

Special thanks to our Council, Committees, Teams, Janet Broché, and to each of you for making this a fruitful year of worship, outreach and service at Resurrection. You are welcome to contact me anytime by phone, text or email.
